# **Crossing Guard**

The Crossing Guard works under the direction of the Police Sergeant; prepares crossing zone and assists children in crossing streets safely.

#### **ESSENTIAL RESPONSIBILITIES AND DUTIES**

- 1. Assist children in crossing streets safely while traveling to and from school
  - 1.1 Prepares school crossing zone by turning on flashing lights and placing warning cones in the street
  - 1.2 Takes children safely across the street, watching traffic closely and stopping cars if necessary
  - 1.3 Participates in special events as asked by school administrators and/or sergeant

## **MINIMUM QUALIFICATIONS**

## **EDUCATION, EXPERIENCE AND CERTIFICATIONS**

Graduation from high school or GED equivalent, or any equivalent combination of related education and experience.

## NECESSARY KNOWLEDGE, SKILLS, AND ABILITIES

- 1. Knowledge of current Utah traffic laws; knowledge of emergency procedures.
- 2. Skill in the use of materials, equipment, and tools necessary to cross children.
- 3. Ability to communicate effectively both verbally and in writing; ability to follow instructions; ability to work effectively with children, parents, and school employees.
